

PROFESSIONAL LASER HAIR REMOVAL TECHNICIAN EXAM SITE NOTIFICATION

The Texas Laser Institute – Association of Laser Professionals (TLI-ALP) is an approved certifying body by the Texas Department of State Health Services to provide the prerequisite examination for individuals to transition from a Senior Technician to a Professional Laser Hair Removal Technician. As you may already know, every provider under rule 302 is now required to have a Registered Professional Laser Hair Removal Technician on staff.

TLI-ALP is excited to offer a convenient, affordable, and educational examination experience to members and to non-members.

There are presently thirteen (13) examination dates scheduled for the remainder of 2012. Candidates will have three (3) hours to complete the 50 multiple choice and the 25 short answer examination. A passing score of an 80% is needed to attain certification. Prior to the examination, TLI-ALP will provide a four (4) hour review course covering the material to be tested. The cost of the review course as well as the study materials is included in the examination fee. (Please see the application for examination costs.)

TLI-ALP will grade all completed examinations within three (3) days of the testing date and promptly issue certificates. Unsuccessful candidates may contact the TLI-ALP and schedule another examination to be conducted at any scheduled testing date or schedule on an individual basis and to be administered in Houston, Texas. The cost for retaking the examination is \$50.00 TLI-ALP is dedicated to the success of each applicant, and following thorough discussion of the examination topics, strives to see very high passage rates.

The four (4) hour review course will begin at 9:00 am with the examination to begin by 2:30 later within the same afternoon.

For each city, the location of the review and examination is listed above. At least five (5) candidates are required to hold the examination. Payment is not processed until the number of necessary candidates is attained.

An application for examination as well as payment is required 7 days before the examination. Late applications will be accepted based upon space and availability. Study materials will be sent via e-mail or US Postal Mail several days prior to the examination date as well as confirmation of enrollment.

Certification is valid for three years. Members and non-members alike must achieve 8 hours of approved continuing education every three years to maintain certification as well as show evidence of recent full-time employment, or retake the examination.

Review courses are typically taught by Robert E. Logue, JD, LSO.
